With reference to your application dated **15/06/2012** and subsequent inspection of the school, I am directed to convey sanction for provisional affiliation to the above said school for **Senior School Certificate Examination** for a period of **three years** w.e.f. 01.04.2013 to 31.03.2016 in the following subjects:-

- (a) Languages:- English Core/Elective. Hindi Core/Elective.
- (b) Elective Subjects: Physics, Chemistry, Mathematics, Biology and Computer Science.

The sanction is subject to the fulfillment of the following conditions in addition to the general conditions intimated at the time of grant of provisional affiliation for secondary classes:

- 1. "The school will follow syllabi and courses as per scheme of studies prescribed by the Board for Senior School Certificate Examination and changes made therein from time to time."
- 2. The school will implement Continuous and Comprehensive Evaluation (CCE) as per the schemes of the Board upto Classes X.
 - 3. As per the newly implemented CCE scheme vide Circular No. 39/20-09-2009 dated 20.09.2009, the students of class X will appear in the Summative Assessment-II (SA-II) conducted at the school level only. However, those students of class X, who opt to move out of CBSE system in Class XI to any other Board, will exercise the option to appear in the SA-II conducted at the Board level. Both the students will get the same certificate issued by the Board at the end of class X.
 - The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State Govt./UT.
 - 5. It is mandatory for every affiliated school to become a member in the local sahodaya of CBSE schools.
 - 6. The school will provide additional suitable facilities for classes XI and XII, as per requirements laid down in the rules.
 - It will increase the number of books in the Library and equipments in the Laboratories/Workshops with adequate games facilities etc. in consonance with the requirements of the Board for Classes XI & XII.

Conditions for which compliance to be submitted within three months of issue of sanction letter:-

- Running starting of Class IX/X or XI/XII without prior Provisional Affiliation upto Secondary level/Sr. Secondary level from the Board would be unauthorized and school shall be responsible for the consequences arising out of it.
- Non submission of application for extension of Provisional Affiliation by 30th June of the year preceding to the year by which provisional affiliation granted, expires, would also attract violation of provisions of Affiliation Bye Laws.
- School will not prepare any student/start any class for any other Board except CBSE from their CBSE affiliated school building/premises.
- 4.
